DIRECTIONS TO MEET: From the north – Take I-95 exit 349 (Beach Blvd). Go east about 3 miles to Dean Rd. Turn right and the school is about a block down on the right.

From the south – Take exit 347 (take US-1 Alt/Emerson St.). Turn right. Follow the road to Beach Blvd (about a half-mile down the road, Emerson splits to the right – take either one – they both go to Beach Blvd. Turn right. Proceed as above.

DIRECTIONS TO HOTEL: From north or south – Take I-95 exit 344 (Butler Blvd). Go about a mile to Southside Blvd (highway 115). Go north about a mile to the Hampton Inn on the right.

DIRECTIONS TO MEET FROM HOTEL: Continue north on Southside Blvd to Beach Blvd. Go left about a mile to Dean Rd. Turn left and you are there. SOUTHERN DIVISION WINS NATIONAL AWARD

The Southern Division has won the first quarterly award in the National TCA annual Membership Drive. Every year TCA has a "Challenge" to see which division can sign up the most new members to TCA. So far in this year's contest the Southern Division has signed a greater percentage (based on number of members in the Division) than any other division in the TCA. This is primarily due to efforts on the part of the Board of Directors to push for new members, and our presence at major train shows. For example, we have had a Southern Division booth at the latest "World's Best Hobby on Tour" show in Tampa, and plan to have a booth at the "Great Train Exposition" Show at the Central Florida Fairgrounds in Orlando and at the Florida State Fairgrounds in Tampa, both in August. We plan to use the certificate to get nice door prizes for Southern Division meets.

TCA Southern Division Board of Directors Meeting Minutes, Friday January 28, 2011

Attendees: Charles Anyan, President, Michael Powell, Treasurer, James Herron, Vice President, Arnie Travitsky, Past President, Steve Harris, Second Past President. The meeting was called to order by President Anyan at 1:10 P.M.

President's Report;

- C. Anyan introduced James Herron who has been appointed Vice President by President Anyan according to the Bylaws of the TCA Southern Division.
- The recently appointed Communications Officer is unable to fulfill the office for personal reasons. The duties will continue to be performed by C. Anyan and B. Trappen.
- C. Anyan read the BOD minutes from the last official Board meeting held August 5, 2010.
- C. Anyan gave an update on the Largo meet. Everything is ready for a successful meet tomorrow. C. Anyan also read the substantial list of publications and web sites where the Largo meet was advertised. There is every indication this will be a successful meet.
- C. Anyan reported that everything is ready for the "Night at the Museum" at the Tampa Bay Toy Train Museum. Guests can arrive anytime after 6:00 P.M.
- A. Travitsky agreed to write an article for the next "The Layout" seeking a volunteer to create and maintain a mailing and email list of non-TCA members who have attended Southern Division meets, so we can advise them of future meets.
- To get ready for the Stuart meet, J. Herron and A. Galli spent a day together planning for a successful meet. They are planning to spend \$300 for temporary signs to advertise the meet. Flyers are being distributed everywhere possible.
- For the Jacksonville meet, a new location has been selected. The meet will be held at the Hendricks Day School, which is conveniently located in the Jacksonville area. Jeff Sawyer has agreed to be the Meet Host.

For the Lake Worth meet, Mike Setzer will be the Meet host.

Secretary's Report: There are currently 433 active members in the Southern Division.

Treasurer's Report:

The Income and Expenses for the Maitland meet were reviewed, and approved. The Maitland meet made money.

The Fourth Quarter Treasurer's Report was approved. Details will be printed in the next issue of "The Layout".

The 2011 Budget was presented and approved. This Budget was printed in the last issue of "The Layout."

A brief discussion was held regarding the amount of money in the Southern Division Checking account. The Board directed the Treasurer to put a portion of the checking balance in an interest bearing account.

Old Business: The board discussed having the award ceremony at Clark and Ilene Vegazo's house again in 2011, and C Anyan will discuss this possibility with them.

New Business:

The Officer Election results are in, and the three officers running unopposed for office have been elected.

The new Bylaws were approved by the members.

- M. Powell agreed to work on documenting the roles and responsibilities for the Officers of the Southern Division.
- Some members have not been getting their "The Layout" and the process will be changed to better ensure that all members get their copies of "The layout"
- J Herron reviewed a proposal for a 45th anniversary Southern Division Club Car. The Board was interested and Mr. Herron will make a sample car and have it ready for the Board Meeting at Stuart on 3/25/2011. The Board will further discuss this possibility then.

Mr. Galli reported on tomorrow's meet. Everything seemed to be ready to go with 39 different table holders filling 74 total tables. (All tables have been sold) There are eight gratis tables for displays and Club items. The tables are already set up and assigned and a test track is also available. We discussed advertisement for this meet as well as the ongoing advertisement debate. The board seemed very satisfied with the newspaper, radio, magazine, and flyer ads, as well as 400 post cards mailed to certain people. Set up will start in the morning at 7:00 with doors open to TCA/SD members at 9:00 a.m. The general public will be admitted at 10:00 @ \$5.00 per adult.

Southern Division Board of Directors Meeting Minutes, Friday, March 25, 2011, continued

We discussed the continuing problem of some tables showing up at 6 feet instead of 8 without our prior knowledge. Mr. Dennis recommended that all future ads state that all 8 foot tables will be assigned first and if no more are available, the 6 foot tables will then be assigned. Everyone agreed and it was noted that this will be included in future ads.

Mr. Galli reported on the status of the "Children's Museum of the Treasure Coast" Everyone seemed pleased with the progress and the SD will be involved to some extent. Mr. Galli left the meeting at this time to attend to other business.

President Anyan reported that the SD won an award from the TCA for signing up new TCA members. We received a certificate/plaque plus a gift certificate for \$200.00. Door prizes will be purchased with this money from the TCA store.

The minutes of the last meeting were not read as they had already been approved and published in the last "Layout". Mr. Dennis recommended and it was agreed that minutes will no longer be read at future board meetings unless necessary for the business at hand.

In Jeff Sawyers absence, the President reported on the status of the Jacksonville meet in May. Currently there are no open houses available. Arnie is going to work on this for the club. The meet hall is in a Church/School gymnasium with 7,000 sq. ft. Concession stands will be available by church members and our meet hotel will be the Hampton Inn with rates starting at \$65.00. Everything is very conveniently located.

The Lake Worth meet will again be held on August 20 in the Polish Club with Mike Setzer as host.

Secretary Dennis reported that as of last night, we have 448 active members. The last number assigned was 2579. He requested that every one please inform him of any changes in emails, phone changes, address changes, etc. He can only put into our records the correct information that is made available to him. Report accepted as presented.

Treasurer Powell distributed the financial report on the Largo meet. Bottom line is that it was a very successful meet with a \$1,256.47 profit. Report accepted as presented.

Vice President Herron joined us as soon as he got off work from his office job. He presented a South Florida Submarine Car for us to consider as a possible Southern Division Car. There was a lot of discussion and questions concerning the graphics, cost, selling price, etc. We will have the car available at tomorrows meet and judge the interest shown by the membership. The final decision will be decided in the very near future.

The last old business concerned revisiting the problem of table helpers who come into the show, try to get their own table, or sell their trains off a members table, etc. without being a TCA or Southern Division Member. After a lot of discussion, a motion was made, seconded, and passed to finally answer this problem. It reads, "All table holders and Helpers must be TCA members, or a spouse, or children under the age of 18."

New Business:

We discussed the Maitland meet and what can we do to top last year's event. Some options are to return to Clark's open house again, the possibility of the steam train picnic at Bruce's house, and the back lot tour at the Disney Railroad. The banquet on Saturday after the meet should be continued. The board will continue to work on making this meet successful.

The starting time for all meets was debated and it was generally agreed on to keep it the way it is now. We should not have different start times for different meets since it would only mess up the member's arrival time.

Should we return to having new applicants leave the building so we could vote on them officially becoming members? It was generally thought that if they were able to qualify for membership in the national club, they would also qualify for the Southern Division. It was decided to just introduce new members who joined at that particular meet.

Mr. Powell will put a request in the "Layout" for members to volunteer to help man a Southern Division booth at the train Expo in August in both Orlando and Clearwater.

The subject of per diem and/or mileage for BOD members to attend BOD meetings was discussed. There was no decision and no motion to do so.

TCA Southern Division Submarine Car

The Southern Division of the TCA is producing a Lionel commemorative car, the USS MIAMI. Production of this car will be extremely limited to only those who purchase this car in advance. This Lionel factory-produced Submarine and Flat Car in "O" Gauge will be painted by an independent artist in Art-Deco colors, reminiscent of the glory days of the South Florida Miami area (The photo is the prototype – the actual submarine will say USS MIAMI and have the USS MIAMI logo, shown below, on the side. Other details may vary from the prototype.). It features die-cast metal sprung trucks, and an original Lionel box, modified to say **SSN-755**. This car is hopefully the first in a series of cars to feature cities, places, and events in Florida history, leading up to our 50th anniversary as a TCA Division. Don't miss the first car in this series.

The USS MIAMI is a real submarine **(SSN-755).** It is a <u>United States Navy</u> nuclear <u>attack submarine</u> of the <u>Los Angeles class</u>. Launched in 1988, she is the second U.S Navy ship to be named for <u>Miami, Florida</u>. Although the USS MIAMI is a serious weapon, the toy submarine is only meant to commemorate the ship, and is intentionally produced in bright colors to emphasize that it is only a toy.

Anticipated delivery is expected to be by Christmas this year. Cost of the car is expected to be \$79.00 including shipping. Canadian and foreign orders add \$10.00 extra for shipping. Any profits will be used to benefit activities and operations of the Southern Division of TCA.


