# FORT PIERCE MEET STORY February 2, 2019 The Havert L. Fenn Center

The Fenn Center, 2000 Virginia Ave., Fort Pierce, FL 34982, (772-462-1521) again will serve as the host venue for our 2019 train meet.

**Meet Hours: 8:30A** to TCA members and **9:00A-2:00P** to the general public

<u>Directions</u>: From I-95, take Exit 129. Go East on Rt. 70 (Okeechobee Rd.) for 1.2 miles. Turn RIGHT on Virginia Ave. Go 1.6 miles to the building on the left. From the Florida Turnpike, take Exit 152. Go East on Rt. 70 for 2.1 miles. Turn RIGHT on Virginia Ave. Go 1.6 miles to the building on the left.

<u>Admission</u>: \$5.00/person with free admission to a child 12 and under when accompanied by an adult (limit one per family)

<u>Workshops</u>: Several operating layouts will be on display, but there is room for many more. If anyone wishes to bring a layout or knows someone or a club that might be interested, please contact Meet Host **Al Galli**.

**Hotel:** There is no designated meet hotel but several, reasonably priced, are located at I-95 Exit 129.

Food: Coffee, drinks and snacks will be offered for sale at the Fenn Center.

<u>Table Holders</u>: Early set up currently is scheduled for Friday the 1<sup>st</sup> from 1:30-4:00P and 7:00-9:00A on the day of the meet. All table holders are asked to contact me the week of January 14<sup>th</sup> to confirm that these will be the hours for set up. Electrical power is available (no extra charge), but please specify on your registration form.

<u>Tables</u>: 8 feet, \$20 for TCA SD members and \$30 for TCA non-SD members - <u>remember that all helpers must be a current spouse or a current member of the TCA in good standing.</u>

**<u>Note</u>**: An SD Board of Directors meeting is scheduled for Friday the 1<sup>st</sup> beginning at 3:00P at the Fenn Center. Any SD member is invited; but if you wish to attend, contact VP Jay Zschau (contact info on page 2 of this newsletter) prior to the meeting.

November 16, 2018
Morocco Shrine Auditorium, Jacksonville, FL

- I. Call to order: by President Steve Johnson at 2:05 p.m.
- II. Attendees: President Steve Johnson, Vice-President Jay Zschau, Treasurer Mike Powell, and Communications Officer Bill Trappen. Also attending was Henry Snyder, Jacksonville Meet Host.
- III. Approval of Minutes from Last Meeting: September 2018 Orlando BOD Meeting Minutes previously were approved by email.

TCA Southern Division Board of Directors Meeting Minutes (cont'd):

#### **IV. Meet Reports:**

- A. <u>Jacksonville</u>: Mr. Snyder reported that 50 tables have been sold and 60 tables have been set up. Regarding next year's meet, Mr. Snyder reported that the proposed sale of the MSA facility fell through. He also reported that this is not the first time a sale has fallen through, and it will go back on the market. But due to the lead time involved in completing a new sale, the facility is expected to be available for rental again next November.
- B. Fort Pierce (2/2/19): Mr. Johnson reported that meet host Al Galli told him at York that it was going OK.
- C. <u>Largo</u> (4/27/19): a phone call was made to meet host Charlie Anyan who reported that he has locked in the date and will finalize a contract with the facility rental manager.
- D. <u>Orlando</u>: Mr. Trappen reported that Mike Mills advised him that the Lake Nona Middle School wants us to return to have another meet in 2019. A date of September 21<sup>st</sup> is our first choice to avoid conflicts with other shows and UCF home football games.

#### V. Officers' Reports:

- A. <u>Vice-President's Report</u>: Mr. Zschau reported that just last week letters were sent out to 440 TCA members in Florida who are not SD members inviting them to join the SD and that he had already received responses from that mailing from 7 paid-up new members who joined. More are expected to be received. Mr. Zschau also reported that he is working on the bylaw changes and also that they need to be reviewed by national which we should plan to do before we present them to the membership in a referendum. Mr. Zschau also is planning to revise the Officer's Handbook and is soliciting changes and ideas. Regarding the Awards, no report has yet been received from John Bailey. It was suggested that we again consider having a banquet to present the awards, and it makes sense to have it during the timeframe of the Orlando meet next September. Regarding elections, we will ask for nominations at the business meeting tomorrow. Mr. Zschau also mentioned the TCA "Win Big" recruiting campaign and that despite being a relatively small division, the division can still win a prize for highest percentage new membership growth.
- B. <u>Secretary's Report</u>: in the absence of Mr. Dennis, Mr. Powell unofficially reported that currently we have 397 paid members (not counting the 7 new members mentioned above).
- C. <u>Treasurer's Report</u>: Mr. Powell distributed the Orlando meet financial report along with the 3<sup>rd</sup> Quarter Treasurer's Report. The Orlando meet exceeded financial expectations with a net income of \$500+. Table sales and paid attendance were higher than expected while the facility rental cost was lower than expected. The treasurer's report shows \$16,279.06 in assets as of 9/30/18; however, 2019 dues are now being received. A motion was made to accept the report which was seconded and unanimously passed.
- D. <u>Communications Officer's Report</u>: Mr. Trappen summarized his analysis of the effectiveness of the various advertising sources used for the Orlando meet as shown on the survey of meet attendees. Results showed that placing flyers at other trains shows had the most impact and that the paid ads in <u>Classic Toy Trains (CTT)</u> and <u>Model Railroader (MR)</u> magazines brought in more attendee dollars than they cost. Therefore, Mr. Trappen submitted paid ads in CTT and MR for the Fort Pierce meet. He also identified other places he has been advertising our meets. We still need a webmaster and will ask for a volunteer at the business meeting and in the newsletter.
- F. <u>The Layout Editor's Report</u>: Mary Anyan sent her report by email in which she requested that items for the next newsletter be sent to her not later than December 1<sup>st</sup>.
- G. <u>2020 National Convention Report</u>: Mr. Johnson reported that plans are progressing well for the 2020 Convention and that the hotel has completely renovated the space that had been damaged in the flood due to the hurricane last year. He will put together a budget.
- VI. Old Business: follow-up to Strategic Planning Meeting Mr. Johnson and Mr. Zschau are reviewing the recommendations.
- VII. New Business: Mr. Johnson has received requests from some members for SD shirts. Should we order new shirts? Mr. Johnson will research. The suggestion was made to reverse the colors (green with yellow graphics next time).


Mr. Johnson adjourned the meeting at 4:00 p.m.










**Southern Division "Passings"**
